## SHORT CUTS

### Estimated UI tax penalty waived

If you collected state unemployment benefits last year, and underpaid your estimated tax payments, you will not be required to pay a penalty and interest related to underpaid estimated tax payments, according to the state Treasury Department.

The Michigan Treasury Department said that it has granted an automatic waiver of all penalties and interest related to underpaid estimated tax payments owed by taxpayers who received unemployment benefits in 2020.

Under state law, taxpayers are required to pay quarterly estimated tax payments when the annual tax due is expected to exceed \$500 or more. Taxpayers who fail to pay an estimated quarterly tax payment are typically subject to penalties and interest.

All taxpayers who received unemployment during the 2020 tax year will automatically receive this waiver. "This is the right thing to do," State Treasurer Rachael Eubanks said. "Having to pay penalties and interest on unemployment benefits is the last thing individuals should be worried about when they go to pay their taxes."

### UI Trust Fund is in pretty good shape

The Michigan Unemployment Insurance Agency Trust Fund has paid \$5.1 billion in state jobless benefits since March, but "has one of the healthiest trust funds in the nation," the UIA said Feb. 18.

The agency said it has paid more than \$29 billion in benefits since March 15, 2020, but only \$5.1 billion has been paid in state UI benefits. The rest comes from federal relief benefits.

The fund is built from state taxes paid by employers. The UIA pointed to its "Work Share Program" as a major reason the fund is in the black - the program allows job providers to retain their skilled workforce, avoid layoffs, or bring back workers at reduced hours while employees collect partial unemployment benefits to make up for their lost wages.

### Union attorney moves up at NLRB

President Joe Biden has nominated a union-employed attorney, Jennifer Abruzzo, for the National Labor Relations Board General Counsel position. It's a key position, deciding which cases come before the board.

The White House said on Feb. 17 that Abruzzo currently serves as Special Counsel for Strategic Initiatives for the Communications Workers of America (CWA). Prior to her work at CWA, Ms. Abruzzo was Acting General Counsel at the National Labor Relations Board NLRB, and has spent almost 23 years working for the NLRB in various capacities.

Abruzzo replaces Trump-appointed Peter Robb, a partner at a union-busting law firm - and his actions at the NLRB reflected that background. Biden fired Robb.

## Trades power construction of Lansing BWL Delta plant

DELTA TWP. - The long coal-hauling trains that have fed the two remaining coal-burning Lansing Board of Water and Light power plants will be a thing of the past in the next few years, with the retirement of the Eckert Power Station (in 2020) and the closure of the Erickson Power Station ( slated for 2025).

Their replacement is the 250-megawatt Delta Energy Park, a plant to be fueled by natural gas that's being erected on the grounds of the Erickson plant. Construction of the \$500

million facility is being led by Lansing Power Constructors, a joint venture between Barton Malow and Clark Construction, their subcontractors and a union workforce. "It's by far the largest construction project we have undertaken," said Lansing Board of Water and Light General Manager Dick Peffley. "Despite the impact of COVID, we

have done really well with the construction, and we're very pleased with our contractors (Continued on Page 2)

## Construction employment slips as 2021 starts

U.S. construction activity in 2021 is picking up where 2020 left off.

Looking for traction, the industry started the year slipping a bit, with total construction starts dropping 4 percent in January compared to 12 months prior. The U.S. nonresidential sector, a key union employer, saw building starts flat compared to January 2020, while the stronger residential market fell 4 percent and non-building construction starts (think infrastructure) fell 10 percent. The numbers come from a Feb. 17 report by Dodge Data and Analytics.

Given uncertain weather conditions in much of the nation,

first quarter construction totals can be notoriously uneven from year to year. Indeed, "with only one month of 2021 completed, a year-to-date analysis will provide little useful information," Dodge said. "Additionally, January 2020 (i.e. pre-pandemic) was the culmination of a strong cyclical upswing in construction starts that began in 2010 and thus provides a poor point of comparison.


"An alternative viewpoint for analysis is comparing 12-month totals. For the 12 months ending January 2021 total construction starts were 11 percent below the 12 months ending January 2020. Nonresidential starts were down 25 percent, while non-

building starts dropped 15 percent. Residential starts, however, were 5 percent higher for the 12 months ending January 2021."

Regionally in January, starts

were lower in three of the five regions - the Midwest, South Atlantic, and South Central. Construction starts rose, however, in

## Amazon warehouse unionization vote a new mile-marker for Southern labor organizing

BESSEMER, Ala. (PAI) - Overcoming one final company-crafted hurdle, almost 6,000 workers started mail voting on Feb. 8 on whether to unionize an Amazon warehouse. If the drive to unionize is successful, it would be seen as an historic win for organized labor.

Final results of the balloting, on whether the workers will join

the Retail, Wholesale and Department Store Union, a sector of the United Food and Commercial Workers, will be announced March 29.

The last-ditch hurdle put in by Amazon, which other anti-union bosses have tried, was to force the 5,805 workers to vote in the traditional manner - in the warehouse during time off from their shifts - despite the lack of physical distancing and other

anti-coronavirus measures. The National Labor Relations Board, even with a GOP-named majority, unanimously OK'd the mail ballot.

"Once again Amazon workers have won another fight in their effort to win a union voice," RWDSU President Stuart Applebaum said after the NLRB's Feb. 5 ruling for mail balloting, not in-person voting. "Amazon's blatant disregard for the health and (Continued on Page 3)

## Dems (barely) control Congress - now what?

New hope for retiree-friendly multi-employer pension reform

Labor loves pro-union PRO Act, but it's 'kill bill' for GOP

WASHINGTON, D.C. - Congress is taking another crack at providing relief to a multi-employer pension plan crisis that threatens the financial future of more than one million American workers and retirees.

House Ways & Means Committee Chairman Richard Neal (D-MA) on Jan. 21 introduced the Emergency Pension Plan Relief Act of 2021 (EPPRA), which is an updated version of the four-year-old Butch Lewis Act. "The workers and retirees enrolled in these failing plans did everything right - they put away money year after year to save for their futures, even forgoing pay (Continued on Page 14)

WASHINGTON, D.C. - Like it or not, here comes the PRO Act. For the nation's labor unions, it could usher in a whole new era of easier worker organizing. For many workers it could be the trigger that raises pay and improves benefits, leading to a greater voice on the job and bringing about safer workplaces.

The *National Law Review* on Feb. 4 said: "If enacted, the PRO Act (Protecting the Right to Organize Act) would arguably be the most significant piece of labor (Continued on Page 14)

## Every half-century or so, a union member is picked to run the Labor Department

WASHINGTON, D.C. (via Press Associates) - By a bipartisan 18-4 vote, the Senate committee that handles workers' issues voted for Boston Mayor Marty Walsh, a Laborers Local 223 member, to be President Joe Biden's Labor Secretary.

The vote is a good indication that Walsh has the support of the full Senate to be the first union member to run the Department of Labor since union painter Peter Brennan of the New York Building and Construction Trades Council was picked by President Richard Nixon in 1973.

All 11 Democrats voted for Walsh on Feb. 11, as did seven of the 11 Republicans. Health, Education, Labor and Pensions Committee Chair Patty Murray, D-Wash., did not say when Walsh's nomination would come to the full Senate. The panel's GOP leader, Richard Burr (N.C.) voted yes and said he would do so when the full Senate votes, too.

Walsh would replace GOP

Trump regime Labor Secretary Eugene Scalia, a union-busting corporate attorney known for his anti-worker rulings and push to deregulate everything, thus favoring corporations. Scalia also halted all job safety rule-making and slashed enforcement, even in the midst of a pandemic.

By contrast, Walsh, who is also a past president of the Greater Boston Building and Construction Trades Council, has spent his career fighting for workers and is committed to Biden's "Build Back Better" economy that works for everyone, not just the rich, Murray said.

## Ford's train station reno proceeds, with next-level safety

DETROIT - The renovation of the Michigan Central Station - the train depot built in 1913 that's being transformed by the Ford Motor Co. - is a project proceeding under a commitment to "zero injuries and zero accidents."

A partnership sealing that deal has been formed among the project team on site, including MIOSHA, Ford, and building trades unions and their contractors. Such partnerships are becoming increasingly common, with an enhanced level of safety procedures, education and reminders.

Now comes a rare "Level 3" partnership signed by the parties on Jan. 29. Only the second of its type in Michigan, "the primary goals are specific in scope," MIOSHA says, "and will center around safety training with a focus on workers new to (Continued on Page 14)

### What the PRO Act would do

Workers face multiple hurdles when they try to organize, and employers have too much leeway to interfere with workers' free choice. The federal Protecting the Right to Organize (PRO) Act addresses many of the major shortcomings with our current law, the National Labor Relations Act (NLRA), which is supposed to protect the rights of private-sector workers to organize.

And there are shortcomings in the operations of the National Labor Relations Board (NLRB) which was established to carry out key parts of the law. The weaknesses are exploited by anti-union employers and the union-busting consultants they hire, who intimidate workers seeking to unionize, stall union elections, and erect roadblocks to negotiating union contracts.

Here is some of what the PRO Act would do, if enacted by Congress. **Problem:** Employers can fire pro-union workers with no real consequences. This is illegal under the NLRA, but employers do it anyway.

**PRO Act solution:** The PRO Act establishes civil penalties for employers who violate workers' rights as well as individual liability for corporate officials.

**Problem:** Many employers interfere with the union election process. Under current law, employers are not required to recognize and bargain with a union that is supported by a majority of workers.

Employers also stall the election to buy time to campaign against the union. Employers exploit the law to drag out the scheduling of the election, and then use the time between the petition and the election to campaign against the union.

**PRO Act solution:** The PRO Act addresses employer delay tactics by restoring the representation election process and making clear that the decision over the proper bargaining unit is to be made by workers and the NLRB, not manipulated by employers.

**Problem:** Lopsided communications controlled by employers can mean workers hear only anti-union messages. Employers use their access to workers and control of the workplace to make sure workers understand the employer's views about unionization. Anti-union messages are included in orientation materials for new employees, and employers use company email to broadcast anti-union messages.

Nine in 10 employers require employees to attend mandatory captive-audience meetings – meetings delivering anti-union messages that employees must attend or else be disciplined or fired. Employers legally are allowed to keep union organizers out of the workplace so that organizers are unable to talk directly with employees.

**PRO Act solution:** The PRO Act bans captive audience meetings. It requires employers to allow workers to use company email systems for organizing purposes unless there are compelling business reasons for disallowing this use.

**Problem:** Employers hire union-busters to push back on workers' power. Employers overall spend at least \$340 million each year on anti-union consultants.

**PRO Act solution:** The PRO Act requires prompt disclosure of union-busting activities and closes the loophole through which employers and consultants have evaded reporting.

**Problem:** Employers stall progress toward initial collective bargaining agreements.

**PRO Act solution:** The PRO Act establishes a mediation and, if necessary, arbitration process to ensure that workers and employers obtain an initial collective bargaining agreement when workers first organize.

(Continued from Page 1) and tradespeople, they have been great to work with. We're looking forward to bringing the plant online, it will be the most efficient plant of its type in the United States."

Retiring both the Eckert and Erickson plants will make the BWL the largest utility in Michigan to generate coal-free power by 2025, reducing its carbon emissions by 80 percent.

"Five years ago, we burned 2 million tons of coal a year," Peffley said. "By the end of 2025, that will be down to zero."

The new Delta Energy Park plant is being erected on about 20 acres of a formerly empty lot south of the Erickson plant and its signature red- and white-striped smokestack, which was built along with the plant in 1973. Ground was broken on the Delta project in May 2019, and load generation is expected to commence in May. Substantial completion of the plant is expected in October 2021. The site is located at Millett Highway and South Canal Road.

Barton Malow says the natural gas-fired combined cycle Delta Energy Park will be home to three Siemens SGT-800 gas turbines, two Vogt Heat Recovery Steam Generators, and one Doosan steam turbine. The combustion turbines are each capable of 57 megawatts, and the steam turbine generator is ca-

pable of 90 megawatts. Auxiliary equipment will include a heat recovery system, air inlet filtering, closed-cycle cooling, exhaust stack, distributed control system, a switch yard, emission controls and noise controls.

The new 155,000 square-foot Delta plant will be fed from a 12-inch natural gas pipeline under 250 lbs. of pressure, which taps into a Consumers Energy main about nine miles away.

BWL Project Manager Roberto Hodge said earlier this month that the project is employing about 400 tradespeople, putting it at peak employment. He said the project was shut down for only two days due to the

COVID-19 virus, but significant productivity was lost as the utility and its contractors looked for ways to make certain the project could proceed safely.

"It took us about two months to ramp back up to where we were before the virus, and it added about \$15 million to the cost of the project," Hodge said. "We did a lot of re-thinking, and made some good, positive changes, because we wanted people to feel comfortable working here. I think we've done that."

The BWL has kept the building trades busy in recent years. In 2013 the utility started its

movement toward reducing its carbon footprint by erecting a \$182 million, natural gas-fired power and steam generation facility in Lansing's REO Town. In 2020 a new \$27.9 million substation was completed, also in REO Town. Peffley said the BWL is currently undertaking about \$60 million in capital improvement work.

The Erickson plant has been operating at full capacity during construction, and it will continue to do so, Peffley said – but its end is near. "This new plant is a very big part of our future," Peffley said. "It's our bridge between burning coal and moving toward being 100 percent renewable."

# BUILDING MICHIGAN: Muskegon's Michigan Theater HISTORY IN THE MAKING

The presence of at least one prominent, historic and operating theater in a community's downtown isn't necessary for its success, but it sure does help.

Whether they were originally constructed for vaudeville, stage shows or movies, historic theaters are a common touchstone in a community, a place where everyone has been invited to visit over the years to laugh at a comedian, listen to a musical act, or watch a movie.

Such theaters are usually on a city's main street, are often one of the coolest buildings on the block, and the number of people who are happy when an historic theater is closed or demolished should be zero.

"The impact and importance of the performing arts on the cultural and economic life of American cities has been felt since the very first theater and vaudeville houses sprung up on main streets throughout the country," said Michael R. Schnoering, fellow of the American Institute of Architects for the Theater Historical Society of America. "The historic theaters that remain from the pre- and post-World War II eras, as well as those from the mid-20th Century, represent innovative (and sometimes highly ornate) examples of some of the best architectural work of the day, by some of the most heralded architects of their time."

So we're looking at you Frauenthal Center, Muskegon's wonderful historic downtown theater that survived an economic depression, a closure, and calls for its demolition. Opened in 1930 as the Michigan Theater, today the site acts as a multi-purpose venue for movies, live performances and even weddings.


Located prominently at Third and Western Avenue, construction of the 1,726-seat theater came at a time when Muskegon was thriving, and already had several theatres.

"Originally known as the Michigan Theater, the Frauenthal Center was built in 1929 by Muskegon's movie mogul, Paul Schlossman, under the direction of famous theater architect, C. Howard Crane," says the Community Foundation of Muskegon County, which operates the site. "The architectural styling of the theater is Moorish, or Spanish renaissance, and gleams with extraordinary gold accents, cherubs and griffins. Built as a theater for '100 percent all talking motion pictures,' the theater built up a rich history as a glamorous entertainment destination...."

Between 1915 and 1917, Schlossman had previously hired architect Crane to design three of Muskegon's great theaters – the Rialto, Majestic and Regent (all subsequently demolished) and the Strand in Muskegon Heights in 1923.

"Muskegon's massive Frauenthal Center," says *Best Things Michigan*, which lists the venue at No. 8 on its list of the "nine most incredible theatres in Michigan." "offers quite a bit in one package. Built in 1929 – seemingly a fairly big year for Michigan theater – the Frauenthal Center was originally the design of an architect which developed three of the greatest movie houses in Muskegon, sufficient that these were considered on par with most anything else 'outside of Detroit.'"

Indeed, the Roaring 20s was a grand era for theater construction in Michigan, and it was com-

mon for smaller communities or local benefactors to cough up big bucks to fund the hiring of big-time architects like Crane for the construction of a local theater that would bring bragging rights and claim the best "outside of Detroit" designation.


Some of those include the Strand (1921) in Pontiac, the Soo (1929) in Sault Ste. Marie, and the Temple (1926) in Saginaw, just to name a few.

Schlossman made a terrific impression in Muskegon with the new Michigan Theater, which was described by the *Muskegon Chronicle* prior to its opening on Sept. 16, 1930. With the Great Depression nearly a year old, there was no grand opening night event.

"When the doors of the beautiful new Michigan Theater are opened to the public Tuesday for its premier showing, theatergoers of Muskegon will be given the opportunity of visiting and seeing one of the most modern and best-equipped amusement houses in the state," the *Chronicle* said. "The new building, completed and equipped at a cost of more than \$600,000 (\$9.3 million in 2021), today takes a place of prominence among Muskegon's growing group of architectural gems – symmetrical masses of brick and stone which have replaced, in the last half-decade, a number dilapidated tenement houses and ramshackle structures of another day.

"Located at Third Street and Western Avenue in the heart of the business district, the new edifice, with its modern and ornate design and its cream-colored terra cotta exterior, lends color and dignity to the lower end of the city's main thoroughfare. Particularly at night with 1,500 incandescent lights aglow, the building is transformed into a marble-like monument of grace and beauty.

"This same beauty of grace and design which marks the exterior of the structure is carried out in an even more lavish degree in the auditorium of the theater proper, where highly colored materials, rich draperies, graceful arches, ornamental light fix-

tures, heavily carpeted aisle ways, all add to the tasteful appointment of the building."

An advertisement at the time in the *Chronicle* proudly stated, "With the opening of the new Michigan Theater, Muskegon can boast the best in Michigan, outside of Detroit, and second to none in the United States for a town our size." The theater was erected by the Strom Construction Co.

A history provided by the Frauenthal Center said the building's "ceiling and walls were adorned with beautiful ornamental light fixtures, the carpet and opera chairs covered with rich velour, and the stage enclosed with lipstick red draperies. Many ornate carvings, arches and intricate plasterwork abound. The ceiling is surrounded by plaster shells and comes to a large acoustic dome, or oculus, in the center. Suspended from the roof hanging by steel wires, the ceiling is not unlike the suspended acoustical ceilings with which we are all familiar."

The theater was also given a Barton organ, a rare and expensive addition to any venue.

Showing signs of wear in the 1950s, the Michigan Theater's lively interior colors were coated with a pale beige – not an uncommon desecration in the 1950s.

Schlossman's company met its demise in the late 1960s, and the theatre was closed in the early 1970s to 1976. Fearing demolition of the building, a citizens group approached the Community Foundation for Muskegon County, which had received a substantial gift from a local industrialist, A. Harold Frauenthal, who wanted his gift to be used for the good of the community.

In 1976, the Community Foundation used the funds to purchase an entire block of West Western Avenue, including the Michigan Theatre. Frauenthal's name was put on the theatre.

In 1995, Muskegon County voters passed a \$16 million bond issue, and work began in 1998 to restore, improve and expand the theater building and nearby buildings.

## Construction employment slips in 2021

the Northeast and West. "The tenuous beginning to construction starts in 2021 highlights the long and rocky road ahead for the sector this year," said Richard Branch, chief economist for Dodge Data & Analytics. "Over the course of the year the economy will recover as more Americans receive their vaccinations. However, the construction sector's recovery will take time to materialize due to the deep scars caused to the industry by the pandemic. Patience will be key in the months to come."

In terms of construction employment, the sector dropped a bit in January, ending eight months of recovery after the pandemic-related losses from earlier in 2020, said the Associated General Contractors on Feb. 5.

Construction employment dipped by 3,000 to 7,392 million in January from a downwardly revised December total, the Associated General Contractors reported Feb. 5. Employment in the sector remains 256,000 or 3.3 percent lower than in February 2020, the most recent peak.

Unemployment in construction soared over the past 12 months. The industry's unemployment rate in January was 9.4 percent, compared to 5.4 percent in January 2020.

"The stagnation in construction employment in January may foreshadow further deterioration in the industry as projects that had started before the pandemic finish up and owners hold off on awarding new work," said Ken Simonson, the AGC's chief economist. "With so much of the economy still shut down or operating at reduced levels, it will likely be a long time before many nonresidential contractors are ready to hire again."

nominated Walsh a month before, Laborers President Terry O'Sullivan praised the mayor as "a hard-charging, hard-fighting, tireless and tenacious working-class warrior whose word is his bond, who says what he means and means what he says, and who can always be counted on to stand with working men and women. Marty never forgets where he came from. He values hard work and those that do it, and he has seen, first hand, the power of the union movement to transform lives."

Walsh will again make DOL "a powerful guardian of workers and a strong and effective enforcer of labor laws," O'Sullivan added.

As mayor, Walsh won extra support for nurses, sanitation workers and other "essential workers" during the pandemic, said Murray. He's also built coalitions with business on issues such as greater apprenticeship opportunities for women and workers of color.

And his political experience, as a state legislator and union leader, as well as mayor, make him a credible advocate among lawmakers for the Protect The Right To Organize (Pro) Act, which Biden and Walsh strongly support.

Murray added: Workers "need a Secretary of Labor like Mayor Walsh who will act quickly to keep workers safe, defend and expand workers' rights, and be a partner in helping our economy come back stronger and fairer for all workers."

## Amazon unionization vote a new marker for organizing the South

safety of its own workforce was demonstrated yet again by its insistence for an in-person election in the middle of the pandemic.

"Today's decision proves that it's long past time that Amazon start respecting its own employees, and allow them to cast their votes without intimidation and interference."

If RWDSU wins, it would mark a double breakthrough for organized labor in two notoriously hostile environments: Amazon and Alabama. Only 8 percent of the state's workers were union members last year, a Bureau of Labor Statistics survey reported. And while union density rose around the U.S. in 2020, it declined in right-to-work Alabama.

Meanwhile, Amazon hired 400,000 new workers last year to deal with huge increases in shipping volume due to the coronavirus pandemic, Kevin Vasquez reported in Harvard Law School's *On Labor* blog.

Amazon's also notoriously anti-union, even though it could easily afford to pay its workers higher, living wages. Its owner, Jeff Bezos, is one of the three richest people in the U.S. None of Amazon's facilities in the U.S. are unionized.

The *Washington Post* reported in early January that Bezos's wealth grew to \$186 billion, up by roughly \$70 billion during the pandemic.

Appelbaum told Reuters earlier that top union officials had discussed the organizing drive with top aides to new Democratic President Joe Biden, a strong union backer, just after the Jan. 20 inauguration. He did not disclose who talked, or the Biden aides' response.

Appelbaum stressed the importance of the Bessemer campaign to the entire labor movement and its effort to break through in the notoriously union-hating South. There, bosses and politicians in the racially antagonistic and stratified society often play off Whites versus Blacks to thwart union organizing drives by depriving workers of local community support. Most of the Amazon workers are Black in a 70 percent Black city.

Amazon "has a long and well-documented history of workplace abuses, poor working conditions and illegal labor practices," Vasquez added. "A successful union campaign could incite a flurry of organizing activity and spread rapidly to its other warehouses."

Amazon grudgingly admitted in September that the coronavirus had infected more than 19,000 of its workers. It refused to say how many have died. It hasn't released figures since then. Lack of protection against the virus is a key issue for the Bessemer workers.





## Union leaders meet with Biden over infrastructure

WASHINGTON (PAI) – Democratic President Joe Biden and Vice President Kamala Harris talked nuts and bolts with U.S. union leaders on how to rebuild the nation's decaying, aging infrastructure – a goal all of them share.

Biden said infrastructure would be a top priority, once his \$1.9 trillion American Recovery Act passes, designed to help workers and the economy pull out of the coronavirus-caused depression which shot joblessness up into double digits.

And he shrugged off the infrastructure price tag, which itself could be in the trillions.

“It’s not about money. It’s about the nation’s needs,” the president said.

“For working people, this was the most productive Oval Office meeting in years,” AFL-CIO President Richard Trumka, who led the delegation, said after the sit-down on Feb. 17.

“The president and vice president share our belief that rebuilding our infrastructure is critical to our communities. President Biden ran on a promise to build back better. As we made clear today, America can only build back better if unions are doing the building.”

“I asked them to come in,” Biden said. “We want to talk about the Recovery Act we have here that we’re trying to pass – and I think it’s going to get done – and building infrastructure in this country.”

“We are so far behind the curve. We rank something like 38th in the world in terms of our infrastructure – everything from canals to highways to airports to everything we can do, and we need to do, to make ourselves competitive in the 21st century.”

Trumka agreed the Recovery Act must come first, but said union members can trust Biden on infrastructure, because Biden’s always been “a union guy.”

“If we make key structural changes to our economy, we can create a new generation of good-paying union jobs. That means delivering long-overdue COVID-19 relief to working families. It means passing urgently needed infrastructure spending,” Trumka’s post-meeting statement said.

“And it means strengthening working people’s freedom to organize a union by passing the Pro (Protect The Right To Organize) Act. President Biden understands how urgent this is, and we’re looking forward to getting it done as quickly as possible,” Trumka explained.

Infrastructure investment has been a particular union cause for years, just as the American Society of Civil Engineers keeps giving U.S. infrastructure grades of D+ or worse due to aging bridges, airports with pitted runways, elderly railroads, creaky subways and bus fleets that desperately need replacement.

Biden agrees, and construction union leaders, including those at the White House session, keep re-emphasizing that such investment would produce hundreds of thousands of well-paying family-supporting jobs. Biden said so, too. He predicted workers’ incomes and the economy “grow in a way we haven’t seen it grow in a long time” via infrastructure spending.

Neither Trumka nor Biden divulged details of the plan, but Biden said U.S. infrastructure must be built with union labor – a

point he repeatedly emphasized during the 2020 campaign and bluntly told to top business leaders several weeks ago.

And construction workers need the jobs. The latest federal figures, for January, showed construction firms shed 3,000 workers that month, compared to gaining 58,000 in January 2020, before the coronavirus pandemic hit. And there were 938,000 unemployed construction workers in January 2021, while the sector reported a 9.4 percent jobless rate. Exactly a year before, both figures were just over half: 515,000 jobless and a 5.4 percent rate, in winter.

Biden’s plan, to be released, “will create millions of family-supporting union jobs. The plan is exactly what our nation needs,” said Laborers President Terry O’Sullivan, one of the other union leaders in the meeting.

He said Laborers “are ready for the job. It is time to restore the economic well-being of America’s workers and address our long-overdue infrastructure investment needs.”

The Washington Post reported unionists discussed a \$4

trillion multi-year plan. “Any just recovery will build a pathway to economic security and workplace dignity for the millions of working people who have already sacrificed too much,” added AFL-CIO Secretary-Treasurer Liz Shuler, an Electrical Worker. “As I told President Biden, that path runs directly through the labor movement. A union card is the single best tool we have to advance racial justice and gender equity on the job.”

Besides Biden, Harris, Trumka, Shuler, and O’Sullivan, others in the meeting were North America’s Building Trades President Sean McGarvey and union presidents Lonnie Stephenson (IBEW), James Callahan (Operating Engineers), Painters President Ken Rigmaiden, Plumbers and Pipefitters President Mark McManus, Ironworkers President Eric Dean, and Machinists President Robert Martinez.

## Pandemic's 1-2 punch: 1.38M more seek jobless assistance; life expectancy falls

WASHINGTON (PAI) – The ongoing coronavirus pandemic packed a one-two punch against the nation's workers, federal agencies reported, as almost 1.38 million more people sought federal or state jobless aid in the week ending Feb. 13. Meanwhile U.S. life expectancy dropped by a year, to 77.8 years, in the first half of 2020, another federal report showed.

And that second statistic, which re-emphasized the modern-day plague's impact on people of color – life expectancy for Blacks dropped by 2.7 years – could get worse. That's because the preliminary data from the National Center for Health Statistics covers only the first half of 2020, not the whole year, while coronavirus deaths skyrocketed after Labor Day.

The Bureau of Labor Statistics numbers, as usual, show the huge impact on jobs from business closures forced by the battle against the COVID-19 virus. The 1,378,650 workers who applied for state or federal jobless benefits in the second week of February joined 1,209,925 who sought the aid the week before and the 18,340,161 who were already receiving federal or state jobless checks.

Together, those 20,928,736 people either seeking or receiving jobless aid are equivalent to one of every 6.86 workers in the U.S.

The bad jobless numbers are another argument for Democratic President Joe Biden's \$1.9 trillion American Recovery Act, which the Democratic-run House is putting together. It extends federal jobless benefits, which top off state jobless aid for those who get it, or are the only benefits for "independent contractors" and "gig economy" workers.

Those benefits, now \$300 weekly, are scheduled to end in mid-March. Biden's bill extends them to the end of August and increases them to \$400 weekly.

"In the first half of 2020, life expectancy at birth for the total U.S. population was 77.8 years, declining by one year from 78.8 in 2019," the National Center for Health Statistics reported. That wiped out all gains since 2006. "Life expectancy at birth for males was 75.1 years in the first half of 2020, representing a decline of 1.2 years from 76.3 years in 2019. For females, life expectancy declined to 80.5 years, decreasing 0.9 year from 81.4 years in 2019."

People of color saw even larger declines in lifespans: Three years for Black men, 2.4 years for Spanish-speaking men, 2.3 years for Black women and 1.1 years for Spanish-speaking women.

"The provisional life expectancy estimates do not reflect the entirety of the effects of the COVID-19 pandemic in 2020, or other changes in causes of death, such as the increases in provisional drug overdose deaths through early 2020," the federal agency warned. Deaths rise in the winter, it added.

## Panel's party-line vote OKs minimum wage hike

WASHINGTON (PAI) – The proposed raise in the federal minimum wage to \$15 an hour took another step in Congress when the Democratic-run House Education and Labor Committee included it in the \$1.9 trillion “reconciliation” bill that President Joe Biden seeks to help ease the economic woes of the coronavirus pandemic.

The panel’s section of the legislation was passed over GOP protests against raising the minimum wage for 27 million-32 million workers, depending on whose calculations you cite. The Republicans called raising the wage part of “a radical left-wing agenda.”

Now the wage hike and other pro-worker provisions in committee’s section of reconciliation will be combined with provisions from other panels before the full House votes on the measure, expected by the end of the month.

The minimum wage hike is a key worker cause, as the federal minimum wage for regular full-time workers, \$7.25 an hour, hasn’t risen since 2009. The wage for tipped workers – servers, porters, taxi drivers and others – is \$2.13 an hour. It hasn’t risen in 30 years. The bill equalizes the tipped workers’ minimum and the youth subminimum wage with the regular minimum wage in 2027. It faces GOP Senate opposition, along with that of key Sen. Joe Manchin, D-W. Va.

And support for the “\$15 and a union” led thousands of fast food workers out on a strike, literally or virtually, from coast to coast on Feb. 16.

The raise to \$15 an hour by 2025 “will lift nearly one million people out of poverty and put money into the pockets of 27 million workers, who will accelerate our economic recovery by spending that money in local businesses,” committee chair Rep. Bobby Scott, D-Va., said.

“According to the” non-partisan “Congressional Budget Office, a \$15 minimum wage, even after you account for any employment losses, will put an additional net \$333 billion into the pockets of low- and middle-income workers, outweighing the cost to the federal government.”

The Auto Workers had a pointed reply to naysayers in a tweet: “Despite claims that the cost wage increases will be passed onto consumers, researchers found that a 10 percent increase in the minimum wage raised McDonald’s food prices by just 1.4 percent.”

the industry.”


“The mission of MIOSHA is to protect the safety and health of Michigan workers and these types of collaborative agreements help ensure everyone goes home at the end of their shift healthy and whole,” said MIOSHA Director Bart Pickelman. “These construction companies embody the dedication that puts safety and health at the center of the work and they serve as mentors to the other trade contractors on this project.”

“MIOSHA is pleased to partner with Ford, Christman/Brinker, the Michigan Building and Construction Trades Council, and all of the trade contractors and workers on this project and thank them for their commitment to safety.”

The Michigan Central Station project is host to a new worker Fast Track Job Program. The work experience is a joint initiative aimed at providing a pathway from existing training and onboarding efforts to creating skilled city workers for future construction projects. “These safety and training opportunities help build tomorrow’s workforce,” MIOSHA says. The Michigan Central Station Fast Track Job Program was launched by Ford Motor Company, Christman/Brinker, Detroit at Work, Workforce Development Institute, Barton Malow, SkillSmart and the Michigan Building and Construction Trades Council.

Renovations have been ongoing at Michigan Central Station, one of the few surviving grand railroad stations. The 647,000-square-foot building consists of a 15-story office tower set atop a three-story base that includes a vaulted waiting room, arcade, ticket lobby and concourse.

Ford is transforming Michigan Central Station into the centerpiece of a new mobility innovation district in Corktown to shape the future of mobility and transportation. It will be the place where Ford and its partners “will work on autonomous and elec-

tric vehicle businesses, and design new solutions that make mobility more convenient and accessible through smart, connected vehicles, roads, parking and public transit,” Ford says. “This dedication to innovation and safety created the perfect complement for a focus on project safety as the team delivers a revitalized train station.”

The Christman Co. in a joint venture with L.S. Brinker, A Brinker Co., (Christman/Brinker Corktown Transformation Joint Venture) and alongside the Michigan Building and Construction Trades Council and Michigan Occupational Safety and Health Administration (MIOSHA) are working with Ford on this “unparalleled workforce safety program,” MIOSHA says. “The resulting agreement blends the project leaders with the project’s trade contractors in the signing of a formal safety partnership.”

“This is a pivotal project for Ford, for Detroit and for the hundreds of workers that are restoring one of the city’s greatest historic assets,” said Wendy

Burkett, Ford’s director of global safety. “The safety of workers is our number one priority and we welcome the opportunity this agreement provides to unite as one team with MIOSHA, Christman/Brinker and the onsite trades to achieve our goal of zero injuries or accidents. We want everyone who plays a role in restoring this magnificent building to return safe and sound to their families and communities.”

Signing partners were limited at the ceremonial event, as COVID-19 protocols were in place to protect members of the team. In keeping with coronavirus safety practices, trade contractors will have the opportunity to sign the agreement electronically as they join the team.

“On behalf of our building trades workers, we’re delighted to be involved in renovating this wonderful, historic train station, where there is such an intensive focus on safety practices,” said Devlin. “We’re glad that MIOSHA, Ford and the Christman/Brinker team recognize

## New hope for pension reform

raises to do so,” Neal said in a statement announcing the introduction of the legislation. “We cannot allow more than a million men and women to lose their hard-earned savings when we have the ability to stabilize these plans. Passing this legislation is simply the right thing to do.”

The National Association of Plan Advisors said concerning the 2021 version of the Democrat-backed plan before Congress (and we bold-faced the really important stuff): “Under the program, a plan would receive enough financial assistance to keep it solvent and funded for 30 years – with no cuts to the earned benefits of participants and beneficiaries, according to a summary. Plans that previously cut benefits would have to restore them to the retirees who earned them. In exchange for the financial assistance, each plan would have to comply with certain conditions, and would be required to file regular comprehensive reports to PBGC and to the congressional committees of jurisdiction.”

Since the Great Recession more than a decade ago, some U.S. multi-employer pension funds have been beset by a declining base of employers participating in the plans, an increasing population of retirees drawing pensions, and reduced man-hours for workers contributing to the plans. And of course, the coronavirus has just made everything worse.

The IBEW, Boilermakers and Teamsters are the only building trades unions that have actively supported the new plan, called the “Butch Lewis Emergency Pension Plan Relief Act of 2021.” The bill, named for a deceased Teamster who advocated for it, is also supported by the Mine Workers, the AFL-CIO, and a host of other smaller unions like the Bakery Workers who have multi-employer pensions. “These provisions are critically important and long overdue for the more than one million multi-employer pension plan retirees who have been living in fear that they will lose the retirement income they have earned after a lifetime of hard work because their plans and their insurance backstop, the PBGC multi-employer guaranty fund, are headed for insolvency,” wrote AFL-CIO Director of Government Affairs William Samuel in a Feb. 10 letter to Neal.

Plan Advisors added that “one of the key provisions is the creation of a special partition program that would expand PBGC’s existing authority to partition certain troubled multi-employer pension plans, increase the number of eligible plans and simplify the application process.”

*Plan Sponsor* magazine’s analysis said of the updated legislation: “Simply put, the loan-based solutions included in the Democrat-supported Butch Lewis Act have failed to gain traction in the full Congress. Republicans, for their part, seem to favor a ‘partition-based’ proposal advanced last year in the Senate.”

The GOP-backed process of partitioning, *Plan Sponsor* says, “would create a system whereby the ‘sickest plans’ can enact a ‘partition’ option that essentially spins off part of the stressed pension, to be taken over by government insurers or other parties.”

Jackson Lewis P.C., writing commentary on the legislation for JDSupra, said the partition procedure divides a multiemployer pension plan into two, “with the Pension Benefit Guaranty Corporation accepting financial responsibility for the portion of the plan representing the benefits of participants for whom no contributions are being made.”

Under current law, PBGC has limited authority to partition certain troubled multi-employer pension plans. The new legislation, the EPPRA, would increase the number of plans eligible for relief and simplify the application process, Jackson Lewis said.

A fact sheet on the legislation by Democrats said the Congressional Budget Office (CBO) has not yet provided an official cost estimate of EPPRA this Congress. However, last year, the CBO scored similar provisions at \$52 billion over a 10-year budget window.

During an Education and Labor Committee hearing on the multi-employer pension crisis last Congress, the Dems said an actuary estimated that if Congress does nothing to address the multi-employer pension crisis, the total costs to the taxpayers (in terms of lost tax revenue and increased social safety net spending) would be \$170 billion to \$240 billion over the 10-year budget window.

Last year’s Trump Administration budget proposal for 2021 noted that the PBGC’s multiemployer plan program is in “dire financial condition” and projects that it will be insolvent by 2025, at which point participants in insolvent plans would see their guaranteed benefits cut by as much as 90 percent.

The law firm Morgan Lewis said that while a Democrat-controlled government would “likely result in an agreed-upon solution that can move forward,” combined with the “greater urgency” wrought by the PBGC’s looming insolvency, the future for multiemployer pension reform is murky in a Congress that has been dysfunctional. “The likely solution is somewhat difficult to predict at this point,” the firm said.

Late last year the two leading GOP senators negotiating a new plan for troubled pensions said despite bipartisan “significant changes,” during negotiations, we have yet to find an agreement that satisfies our respective principles and objectives for resolving this situation.”

More than 50 Teamster pension plans have high hopes for the 2021 Democratic plan – including the extremely troubled Central States Pension Fund – which would be eligible for support at the outset of the bill’s enactment, with more of the union’s plans becoming eligible in 2022.

“The Teamsters congratulate House Ways & Means Chairman Richard Neal and others on the panel who stood up for hardworking Americans and retirees who only want to receive the benefits they worked hard for by taking less in their weekly paycheck,” Teamsters General President Jim Hoffa said. “We must fulfill this pension promise.”

## Labor unions loves the PRO Act

legislation since the National Labor Relations Act was passed in 1935.” The U.S. Chamber of Commerce hates it. Under its website’s heading “Stop the radical agenda,” the business group said: “Unions and their allies are promoting a bill that would destabilize America’s workplaces and impose a long list of dangerous changes to labor law.” Whoa. The National Retail Federation calls it “the worst bill in Congress.”

The anti-union contractor group, the Associated Builders and Contractors, hates it too. “This undemocratic bill would strip workers of entrepreneurial opportunities to freelance as independent contractors, denying them the freedom to earn a living on their own terms and pursue the American dream,” said ABC CEO Michael Bellaman. “The PRO Act would do anything but ‘Build Back Better.’”

President Joe Biden, the inventor of the slogan “Build Back Better,” begs to differ. “Biden,” it says at JoeBiden.com, “strongly supports the Protecting the Right to Organize Act’s (PRO Act) provisions instituting financial penalties on companies that interfere with workers’ organizing efforts, including firing or otherwise retaliating against workers. Biden will go beyond the PRO Act by enacting legislation to impose even stiffer penalties on corporations and to hold company executives

personally liable when they interfere with organizing efforts, including criminally liable when their interference is intentional.”

Labor unions, of course, are pushing for its passage, big time. “The PRO Act is our crown jewel,” said AFL-CIO President Rich Trumka. “A national commitment to union organizing started in the New Deal that can now be finished by the candidates we elected. Legislation that will give tens of millions of working people access to our movement and hold anti-union corporations accountable in a real way.”

So in that contentious environment comes separate but equal U.S. House and Senate bills, introduced by Democrats in both chambers on Feb. 4.

Michigan Congressman Andy Levin (D-Berkeley), co-sponsor of the PRO Act in the House, said: “At a time of national crises of public health, worker safety and racial inequity, no single reform could do more to rebuild the middle class than restoring the freedom for workers to form a union and bargain collectively. Unfortunately, we’re also seeing corporations exploit a pandemic to deny workers their rights to do so. Now more than ever, workers need us to pass the PRO Act and enshrine the freedom to organize for good-paying jobs with safe working conditions and better benefits.”

Sen. Gary Peters (D-Mich.),

a sponsor of the bill in the U.S. Senate, said: “This pandemic has had an incredibly harmful impact on workers – especially people of color. I’m proud to stand in solidarity with Michigan and American workers against efforts to decimate workers’ rights and join with my colleagues in introducing this bill. We must continue to fight to ensure that every American who works hard and plays by the rules will be entitled to a living wage and benefits – the ability to band together and collectively bargain – and when all is said and done – the ability to retire with dignity.”

Management attorneys Fisher Phillips said the PRO Act contains a “mind-boggling number of sweeping initiatives.” So what are its chances in Congress, where Democrats hold a slim majority in the House and an even slimmer majority in the Senate, and where Dems would almost certainly have to do away with the 60-vote super-majority to avoid a GOP filibuster?

“Even if the filibuster is eliminated, it’s uncertain whether all 50 Democratic senators most likely necessary for passage would agree to such sweeping legislation,” a Fisher Phillips analysis says. “Nonetheless, President-elect Biden has underscored that the policy interests of organized labor will be a priority for his administration.... On that basis alone, it is important for all employers to understand the

significance of its potential components.”

Says the *National Law Review*, which suggested that some of the aspects of the law could be adopted piecemeal: “...whether it will pass Congress still remains a question. Democrats have control of both houses, but in 2009, a Democrat-controlled Congress fell short in a similar attempt at a labor law reform by failing to pass the Employee Free Choice Act. Regardless, changes at the NLRB seem to already be underway.... Employers can expect more union changes under the Biden administration on the horizon.”

On a frosty winter morning, two anglers are on their way up to the first fishing hole on their favorite steelhead river.

As the father and son gear up, the only sounds they hear are the water running and the snow crunching beneath their feet.

Over the next 10 minutes, these woods will awaken with the sounds of chickadees and other birds. As the sun cuts through the clouds, it melts frost off the branches, dripping into the river's slow, churning waters.

Anticipation gathers within the minds of the two men, with a looming battle of epic sport about to occur.

The son looks at his dad, who nods back. They know within the first three casts they are going to have a fish on the line.

The first cast passes the bait through the water with no takers. Any minute now. "Right about there," the father mumbles as he casts.

Almost immediately, the float on the line drops and the water erupts. Out comes a shiny, chrome steelhead, fighting with all its might, trying to shake the hook.

This time of year, steelhead battles are creating magical memories like this across the Great Lakes State.

Michigan provides access to half of all the fresh water in the United States, thanks to four of the five the Great Lakes, more than 11,000 inland lakes, and 36,000 miles of navigable rivers and streams.

This enormous volume of water, and the state's world-class fisheries it supports, provide fishing opportunities of all kinds in every season.

During late fall and early winter months, steelhead river fishing becomes a prized pastime for anglers seeking a unique challenge.

Steelhead is a name given to migratory rainbow trout that are born in rivers but spend most of their lives in the ocean or the Great Lakes. Steelhead are not native to Michigan.

These beautiful fish, first brought to Michigan waters from the west coast in the 1885, are

# Michigan's tasty, feisty steelhead

known fighters that provide great table fare – a combination making them a popular sport fish in Michigan.

Hayden Gosen, a fourth-generation steelhead angler from Sanford, in Midland County, caught his first steelhead on the Pere Marquette River at a young age, with guidance from his father, Craig Gosen.

The Pere Marquette, Muskegon and Hersey were the first three rivers in Michigan to have steelhead stocked in the late 1800s.

"I actually caught my very first steelhead on my own when I was 5 years old," Hayden said. "The passion, the thrill, the adventure, the chase of catching a wild steelhead that's traveled all the way from the Great Lakes up into these rivers ... I never know what the next cast is going to bring and that's the adventure I'm always chasing."

Steelhead river fishing has provided a generational influence that has fueled the Gosen family's interest and enjoyment of Michigan's natural resources for more than 70 years.

Craig was born and grew up in Spaulding Township and learned the sport of steelhead fishing from his grandmother, Mary Vleet, during visits with family on the East Branch of the AuGres River in Iosco County.

"I started going to the East Branch of the AuGres River and got my first steelhead when I was 7 and I was hooked on it at an early age," Craig said.

When Hayden was old enough to fish, Craig mentored him and passed on his knowledge of the sport through many fishing trips. The two have bonded

and spent a lifetime together chasing steelhead.

"He's taught me everything I know," said Hayden, who today lives in metropolitan Detroit. "There is no way I would be an avid angler if he wouldn't have taught me everything he knows, and if his grandparents wouldn't have taught him what they knew."

Hayden recalls that before he could even walk, Craig would tow him in his little red wagon down the banks of the AuGres.

"Steelhead fishing to me, it's a passion. I have a love for it," Hayden said. "That passion was instilled at a young age. For

years, until I could catch fish on my own consistently, I was my dad's 'net man,' his right-hand man."

Like most sportfishing adventurers, the Gosens find significant meaning and connection in participating. Little things, like taking a break and enjoying a sandwich together while sitting on the riverbank, help create lasting memories.

Fishing together is special for the Gosens. "The bond between a father and a son sharing the same passion together – now that's priceless," Hayden said.

"I enjoy the challenge, the thrill, the fight of catching a steelhead. It's gonna be that next memory that I'll remember for the rest of my life. That's what keeps me going, what will that next cast bring me?"

The Michigan Department of Natural Resources manages the state's steelhead populations through numerous fisheries management activities, including fish stocking and regulations.

The Wolf Lake State Fish Hatchery, established in 1927 near Kalamazoo, and the Thompson State Fish Hatchery, opened near Manistique in 1922, rear Michigan's steelhead that are stocked in public waters.

"Michigan's steelhead planting program has really expanded fishing opportunities to countless rivers around the state," said Craig, who now lives in Sandford. "I think it's an excellent program."

Steelhead travel from the Great Lakes and spend their winters upstream, finishing their stay

spawning during spring months. Michigan geography offers a plethora of winter steelhead fishing opportunities found in all regions of the state.

During the winter season, Lake Michigan's rivers are among the prime places to find steelhead. Popular destinations include the Betsie, Muskegon, Grand, Kalamazoo and St. Joseph rivers. Some additional rivers elsewhere in Michigan offering steelhead runs include the Cheboygan, Clinton and Huron Rivers – which feed Lake Huron – and the Choccolay River, which flows to Lake Superior.

"There's endless opportunities to steelhead fish in Michigan," Craig said.

In recent years, the DNR has promoted steelhead fishing through various projects, including a steelhead hatchery video produced at the Wolf Lake State Fish Hatchery. The video featured Hayden and Craig Gosen as anglers.

In winter 2020, a second DNR video expanded this effort highlighting winter steelhead fishing, capturing a Sunday scene of Hayden's family fishing on the Pere Marquette River. This video highlights Hayden's journey to locate, hook, fight and land steelhead, surrounded by the snowy banks of a wintery Michigan river.

Anglers interested in trying steelhead fishing can visit Michigan.gov/Fishing to learn more about getting started. A Michigan fishing license is required to pursue steelhead. Fishing regulations are published in the DNR's Fishing Digest, available at Michigan.gov/DNRDigests.

Charter and guide services offer steelhead opportunities around the state. These captains and guides are valuable stewards passing on the sport to future generations.

"Enjoy the surroundings and get outside," Craig said. "The state has tremendous resources to participate in and view. With steelhead fishing, either walking the bank or floating the river, you get to enjoy that all at the same time."
